## GENERAL MEMBER APPLICATION

Application for membership in the Composite Panel Association (CPA) as a General Member is hereby made by the below named Company/Corporation (Applicant). Applicant understands that to be eligible for membership in CPA, the company meets the following criteria (check one only).

**General Member:** Applicant must be a North American producer of Particleboard (PB), Medium Density Fiberboard (MDF), Hardboard (HB) or Other Compatible Products as defined by the CPA Bylaws. Each CPA General Member company is entitled to designate one primary and one alternate representative to the CPA Board of Directors.

**Non-Producing General Member:** Applicant meets the criteria as described above, but does not yet operate facilities in North America though firmly committed either to build or buy such facilities and is in the process of becoming a North American manufacturer. Applicant can demonstrate that a major financial commitment for such construction or purchase has been secured and a construction or purchase process is scheduled or underway. Non-Producing Members shall have all the rights and privileges accorded General Members, except those of appointing representatives to the Board of Directors, voting, holding office or serving on committees unless authorized by the Board. A Non-Producing General Member will automatically become a General Member once it is confirmed that production and shipments have commenced. Dues responsibilities will change concurrently with becoming a General Member.
